#### Requirements for No Physical Presence of Quorum

Due to the Gubernatorial Disaster Proclamation related to (COVID-19 pandemic) and in order to protect the safety of board members, staff, and the public, the public was not be permitted to physically attend the meeting. However, notice was provided to allow the public to attend the meeting via audio or video-conferencing. No members of the public requested to participate. The local district board members and district superintendents could participate by audio or video conference without the physical presence of a quorum of the local district Governing Board members due to the determination that an in-person meeting is not practical or prudent due to the current health emergency.

Mrs. Armour provided a written determination referring to the specific Disaster Declaration citing the public health concern/emergency that applies to the Board and the meeting and directed the Recording Secretary to include it in the meeting minutes;

ensure that any interested member for the public has access to contemporaneously hear all discussion, testimony, and roll call votes; and directed the Recording Secretary to enter into the appropriate minutes of the Board that each Board member participating in the meeting, wherever their physical locations, announced themselves present and verified that they could hear one another and all discussion and testimony.

The Recording Secretary was directed to reflect in the minutes a quorum totaling 9 members present with 8 remote and 1 in person.
