### Therakids Celebrates 25 Years

Therakids, P.C. is the largest contract company in southwestern Illinois that provides occupational, physical and speech therapy services to special education cooperatives and school districts. Working in both rural and metropolitan communities in central and southern Illinois, they provide therapy to over 1,300 students per week.
